Instructions for Paying Citations

A citation has been issued to you. If you have been charged with one of the violations listed below and wish to plead guilty and pay the fine and cost without appearing in court, you may pay the fine by the following methods.

CREDIT CARD: You may pay your fine by credit card on the Internet or at the Anytown Municipal Court. You may make your Internet payment by selecting the payment link on www.anytown.com/depts/court.html.

CASH: Please sign the back of your copy of the citation and mail payment in full. NO PERSONAL CHECKS ARE ACCEPTED. Send money order or cashier's check made payable to the Anytown Municipal Court. If you wish to receive a receipt, enclose a self-addressed stamped envelope with your payment.

If your violation does not appear below or you wish to plead not guilty, you must appear at the date and time indicated on your ticket.
